Members are not affiliated with any products or marketing that would be considered a violation of the World Health Organization International Code of Marketing of Breastmilk Substitutes.

With the principles of BFI informing our themes, ABC offered one teleconference session, one full day conference in 2018, one workshop and partnered with U of C for a film showing.

Workshop

Connecting Threads Workshop. Held on March 7, 2018- Edmonton, AB.

Four members of ABC facilitated a 6-hour workshop to a varied audience of health care providers, peers, and members of first nations and health branch. A first nations mother shared her breastfeeding story with attendees. The Creator's Gift Video was shown. Networking opportunity.

ABC Conference 2018

Supplementation to Protect Breastfeeding- Next Steps. Held on April 20, 2018-University of Alberta, Lister Conference Center, Edmonton, AB.

This theme addressed several of the best practice steps of BFI. Below are the most relevant steps for this conference, please see the BCC website for more information on BFI.

Step 2 Ensure all staff, health care providers and volunteers have the knowledge and skills to necessary to implement the feeding policy

Step 5 Assist mothers to breastfeed and maintain lactation should they face challenges including separation from their infant

Step 6 Support mothers to exclusively breastfeed for the first six months, unless Supplements are *medically* indicated.

Step 7 Facilitate 24-hour rooming-in for all mother-infant dyads: mothers and infants remain together

Step 8 Encourage baby-led or cue-based breastfeeding. Encourage sustained breastfeeding beyond six months with appropriate introduction of complementary foods.

Presenter, Kathy O'Grady Venter. A registered nurse and retired midwife, International Board-certified Lactation Consultant, BFHI/BFI Lead Assessor for the BCC. In 2010 and 2013, Kathy was the recipient of the Canadian Lactation Consultant Association Award for Clinical Excellence.

Work Plan and Logic Model

Thank you to Eileen Chuey for taking the lead to initiate the revision of The ABC Work plan and logic model.

Breastfeeding Committee for Canada (BCC)

An ABC Goal is to support Alberta facilities working towards and maintaining their Baby-Friendly Initiative designation. High River Hospital, Grey Nuns Hospital, Bonnyville Healthcare Centre are all working to maintain their designated status. This year, the Misericordia Community Hospital, Edmonton became BFI designated. ABC assessor and assessor candidates support the BCC at a provincial level to evaluate organizational readiness and achievements towards the BFI designation.

The BCC announced that the Public Health Agency of Canada is funding \$1.3 million over 5 years to improve maternal infant health by increasing breastfeeding rates in Canada. The primary aim of the project is to revitalize and expand implementation of the Baby-Friendly Initiative in Canada. The project will adapt, implement and evaluate a national quality improvement initiative with 25 participating hospitals. Hospitals were invited to apply for this opportunity early 2019. Michelle LeDrew was awarded the position of the National BCC Baby-Friendly Director and will provide leadership to the BCC funded projects.

Provincial /Territorial BFI Implementation Committee Report on 2018 Activities

Alberta PT Representative is Jennifer Splaine and Susan Nolt from the Ministry of Health Office.

Background

The Provincial/Territorial Baby-Friendly Initiative (BFI) Implementation Committee (P/T committee) is one of two standing committees of the Breastfeeding Committee for Canada (BCC). The P/T Committee was first established in March 2001 and restructured in April 2008. (PHAC), All provinces and territories, the Public Health Agency of Canada (PHAC) and Health Canada's First Nations Inuit Health Branch (FNIHB) are represented on the committee. One of the committee objectives is to build capacity for the implementation of the Baby-Friendly Initiative (BFI) in Canada. This is being accomplished through the sharing of expertise, resources, and experiences supporting breastfeeding and BFI best practices. The strong membership allows for effective information sharing between the BCC and the province and territories. Heidi Boyd (Newfoundland) and Lea Geiger (British Colombia) are the co-chairs of the committee.
